In consonance with Ministry of Finance Office Memorandum no.25 (12) E.Coord-2018 dated 03.04.2018, forwarded by the O/o the Comptroller & Auditor General of India New Delhi vide letter no.18 – स्टाफ हक (नियम)/ए.आर./05-2018 Dated 16.01.2019, the Senior Divisional Accounts Officers and Divisional Accounts Officers, Grade – I (Central Government employees posted in Divisions and drawing salary from the State Government Fund) are eligible for reimbursement for newspaper @ Rs.500/- (Rupees five hundred only) per month. The reimbursement is to be made on the basis of certification (Annexure-A) given by the entitled officers on half yearly basis to the office to the effect that the expenditure has been incurred on newspaper.
